Legislators need to hear from their constituents that these programs are critical and essential to children, families, and individuals with disabilities. Take action today!

FEDERAL ACTION ALERTS

- **Tell Congress it must not leave for fall recess without funding Medicaid disability supports to survive the pandemic.** Use ANCOR's [email tool](#) to ask your members of Congress to step up - you're doing your job, and it's time they do theirs.
- **NEW: Join Us NOW to Urge Lawmakers to Address Remaining Urgent Needs in Legislation Before Adjourning.** We ask you to join us in an URGENT FINAL PUSH to send a message to your lawmakers: don't adjourn without passing legislation that includes significant, urgently needed financial relief for nonprofits. We are asking lawmakers to address the urgent remaining needs of nonprofit health and human services providers NOW, before adjourning the 116th Congress. - **Take Action: Fight to Sustain Child Care.** Without significant investment to sustain it through the COVID-19 crisis, the child care system is at risk of collapse. As the Senate makes decisions about the next COVID relief package, they need to hear from you!
